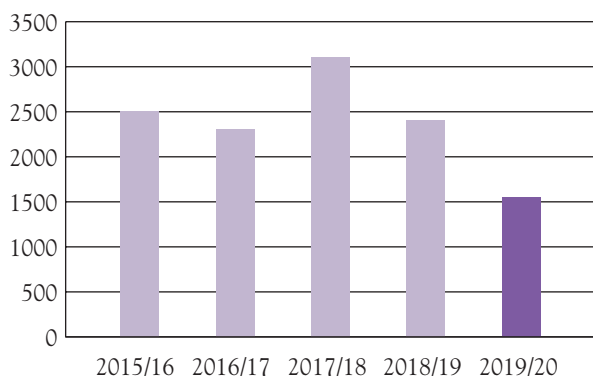
FINANCIAL HIGHLIGHTS

- Basic earnings per share for the year ended 31 March 2020 amounted to HK1.20 cents (2019: HK7.07 cents).

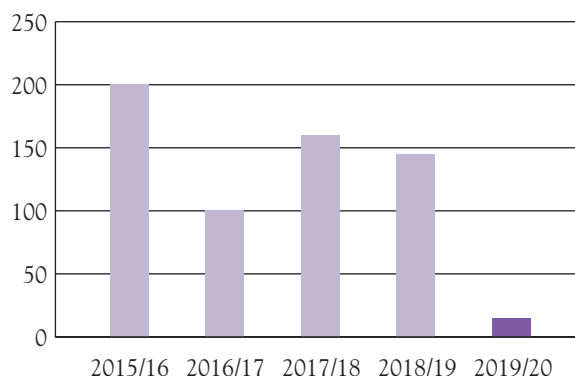

年內溢利(百萬港元)：

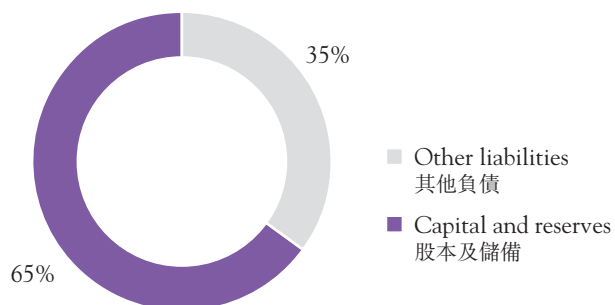

CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the board (the “**Board**”) of directors (the “**Director(s)**”) of Able Engineering Holdings Limited (the “**Company**”, which, together with its subsidiaries, is referred to as the “**Group**”), I report the annual results of the Group for the year ended 31 March 2020.

RESULTS

During the year under review, the Group was engaged in the contract works business, which mainly comprised building construction and repair, maintenance, alteration and addition (“**RMAA**”) works in Hong Kong.

For the year ended 31 March 2020, the Group’s consolidated revenue amounted to approximately HK\$1,548 million, representing a decrease of 35% from HK\$2,385 million for the year ended 31 March 2019. Profit attributable to owners of the parent of the Company for the year ended 31 March 2020 and 31 March 2019 amounted to approximately HK\$24 million and HK\$141 million, respectively, a decrease of 83%. The basic and diluted earnings per share for the year were HK1.20 cents (2019: HK7.07 cents).

The decline in net profit was mainly attributable to (i) the decrease in revenue as certain projects were still in the preliminary stage of development during the year ended 31 March 2020 and the suspension of certain site works in February 2020 to prevent the spread of novel coronavirus (“**COVID-19**”); and (ii) the onetime loss on derecognition (“**Loss on Derecognition**”) of the full remaining net book value of the building portion of Man Shung Industrial Building (“**Man Shung**”) of approximately HK\$41 million following the decision of the Board to demolish it for the redevelopment of the site of No.7 Lai Yip Street, Kwun Tong, Kowloon, Hong Kong (the “**Site**”) where it is located at. The profit attributable to owners of the parent of the Company for the year ended 31 March 2020 would be HK\$65 million if excluding the Loss on Derecognition, a decrease of 54% comparing with last year.

The net asset value attributable to owners of the parent as at 31 March 2020 amounted to approximately HK\$1,255 million (approximately HK\$0.63 per share), representing an decrease of 4% from approximately HK\$1,313 million (approximately HK\$0.66 per share) as at 31 March 2019.

致各位股東：

本人謹代表安保工程控股有限公司(「**本公司**」，連同其附屬公司，統稱「**本集團**」)之董事(「**董事**」)會(「**董事會**」)，宣佈本集團截至二零二零年三月三十一日止年度的全年業績。

業績

於回顧年度，本集團從事合約工程業務，主要包括於香港之樓宇建築及修復、保養、改建及加建(「**RMAA**」)工程。

於截至二零二零年三月三十一日止年度，本集團之綜合收入約為15.48億港元，較截至二零一九年三月三十一日止年度之約23.85億港元減少35%。截至二零二零年三月三十一日及二零一九年三月三十一日止年度，本公司母公司持有者應佔溢利分別約為0.24億港元及1.41億港元，減少83%。本年度之每股基本及攤薄盈利為1.20港仙(二零一九年：7.07港仙)。

溢利下跌主要由於(i)若干項目於二零二零年三月三十一日止年度仍處於初步發展階段及為防止新型冠狀病毒(「**COVID-19**」)擴散而於二零二零年二月暫停部份地盤工作，因而導致收入有所下降；及(ii)萬順工業大廈(「**萬順**」)因董事會決定將其拆卸以重新發展其所處的香港九龍觀塘勵業街7號地皮(「**有關地皮**」)，因而對其樓宇部分的全數餘下賬面淨值約0.41億港元作出一次性終止確認而產生的損失(「**終止確認的損失**」)。如撇除終止確認的損失，截至二零二零年三月三十一日止年度的本公司母公司持有者應佔溢利約為0.65億港元，較去年減少54%。

於二零二零年三月三十一日，母公司持有者應佔資產淨值約為12.55億港元(每股約0.63港元)，較二零一九年三月三十一日之約13.13億港元(每股約0.66港元)減少4%。

DIVIDEND

The Board did not recommend the payment of any final dividend for the year ended 31 March 2020 (2019: HK4 cents per ordinary share).

REDEVELOPMENT OF NO. 7 LAI YIP STREET

The whole block of Man Shung located at No. 7 Lai Yip Street, Kwun Tong, Kowloon, Hong Kong (i.e. the Site) was acquired by the Group through several acquisition transactions in the year of 2018/19. The Group received the formal written approval and permission on 7 January 2020, with conditions, given by the Town Planning Board (the "TPB") in respect of an application made by the Group to the TPB for the minor relaxation of plot ratio and building height restrictions of the Site. Considered the current conditions and facilities of Man Shung, the Board considered redevelopment of the Site into a new non-residential building would be more effective to unlock the potential value and/or gross floor area of the Site than conducting material renovation of Man Shung. The demolition work of Man Shung is in progress.

OUTLOOK

The social unrest since second half of 2019 and the COVID-19 pandemic in early 2020 affected the economy and the property market of Hong Kong. Accordingly, we foresee that there may be a contraction in the private construction sector in the next few years. Despite such uncertain social and economic environment, the community need for the housing and provision of hospital facilities in Hong Kong is still unchanged.

股息

董事會不建議就截至二零二零年三月三十一日止年度派發任何末期股息(二零一九年：每股普通股4港仙)。

重新發展勵業街7號

本集團通過於二零一八至一九年度進行的一連串收購交易購入整棟位於香港九龍觀塘勵業街7號(即有關地皮)的萬順。於二零二零年一月七日，本集團接獲城市規劃委員會(「城規會」)就本集團向城規會要求略為放寬有關地皮的地積比率和建築物高度限制的申請而發出之正式書面批准及有條件的許可。考慮到萬順的當前條件和設施，董事會認為，將有關地皮重新發展為一棟新的非住宅大廈將比為萬順進行大型翻新更有效地釋放有關地皮的潛在價值及／或建築面積。拆卸萬順之工作正在進行中。

前景

二零一九年下半年以來的社會動盪以及二零二零年初COVID-19爆發對香港經濟及物業市場產生不利影響。因此，我們預計未來數年私人建築工程項目將出現收縮。儘管社會及經濟環境不明朗，但社會對香港房屋及醫院設施的需求仍沒有改變。

CHAIRMAN'S STATEMENT 主席報告

The Government of Hong Kong Special Administrative Region (the “HKSAR”) demonstrated its dedication to increase the supply of public housing by increasing the proportion of public housing in overall housing supply to 70% as announced in 2018 Policy Address. In addition, as mentioned in 2019 Policy Address, the HKSAR Government set aside HK\$5 billion to increase the number of transitional housing projects substantially to provide a total of 10,000 units within the next three years, which was further increased to 15,000 units as announced by the HKSAR Government in January 2020. The HKSAR Government also expedited land supply planning work and resumed three types of private land wholly for public housing, Starter Homes and related infrastructure development by invoking the “Lands Resumption Ordinance” (Cap. 124 of the Law of Hong Kong) and other applicable ordinances. Further, the Land Sharing Pilot Scheme announced in 2018 Policy Address will tap market force in housing planning and construction which can release private land lots with consolidated ownership but not yet covered by government planning and study, so as to speed up short-and medium-term housing supply.

To meet the increasing demand for healthcare services arising from an ageing population, the HKSAR Government had planned ahead the necessary healthcare infrastructure and set aside HK\$300 billion as announced in the 2018-19 Budget for such purposes.

Moreover, the Group also strives for developing innovative technology aiming at enhancing safety, environmental protection, health, quality and efficiency in managing projects.

香港特別行政區(「香港特區」)政府決心增加公共房屋供應。誠如二零一八年施政報告所提及，香港特區政府目標將公共房屋在整體房屋供應中所佔的比例提高至70%。此外，於二零一九年施政報告中，香港特區政府亦提及預留50億港元以於未來三年合共提供10,000個(於二零二零年一月香港特區政府公佈進一步增加至15,000個)的過渡性房屋單位。香港特區政府亦加快土地供應規劃及運用《收回土地條例》(香港法例第124章)和其他適用條例，收回三類私人土地作百分百公營房屋及「港人首置上車盤」和相關設施發展。此外，於二零一八年施政報告公佈的「土地共享先導計劃」將善用市場的規劃和建造力量，可望盡早釋放部分政府尚未規劃和研究但已整合業權的私人土地，加快短中期房屋供應。

為應付人口老化導致的健康護理服務需求增長，香港特區政府已及早籌劃醫療硬件設施並於二零一八至一九年財政預算案宣佈已預留3,000億港元用作有關用途。

另外，本集團還致力於發展創新科技，以提升安全、環保、健康、品質及項目管理效率。

CHAIRMAN'S STATEMENT 主席報告

The Directors believe that the construction contracts from the public sector in view of the various development plans of HKSAR Government and our investment in innovation technology will support the long-term growth of the Group's construction business. Looking forward, we will keep looking for different investment opportunities to broaden our source of income and integrate with our business partners in order to reduce construction costs, enhance project efficiency and create synergy, which will create reasonable return for the Group and the shareholders of the Company (the "Shareholder(s)") in the long run.

CHANGE IN BOARD MEMBERS

On 20 February 2020, Mr. YAM Kui Hung ("Mr. YAM") retired from Executive Director after serving the Board for over 3 years. The Chairman and the Board would like to express their gratitude to Mr. YAM for his invaluable contributions during his tenure of service.

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

The following discussions should be read in conjunction with the audited consolidated financial statements of the Company for the year ended 31 March 2020.

PERFORMANCE

During the year under review, the Group was mainly engaged as a main contractor in building construction and RMAA works in Hong Kong. As of 31 March 2020, the Group's substantial contracts on hand were mainly related to building construction works from the public sector.

For the year ended 31 March 2020, the Group's consolidated revenue amounted to approximately HK\$1,548 million, representing a decrease of 35% from HK\$2,385 million for the year ended 31 March 2019. Profit attributable to owners of the parent of the Company for the year ended 31 March 2020 and 31 March 2019 amounted to approximately HK\$24 million and HK\$141 million, respectively, a decrease of 83%. The basic and diluted earnings per share for the year were HK1.20 cents (2019: HK7.07 cents).

The decline in net profit was mainly attributable to (i) the decrease in revenue as certain projects were still in the preliminary stage of development during the year ended 31 March 2020 and the suspension of certain site works in February 2020 to prevent the spread of COVID-19; and (ii) the onetime Loss on Derecognition of approximately HK\$41 million, following the decision of the Board to demolish Man Shung for the redevelopment of the Site. The profit attributable to owners of the parent of the Company for the year ended 31 March 2020 would be approximately HK\$65 million if excluding the Loss on Derecognition, a decrease of 54% comparing with last year.

The net assets value attributable to owners of the parent as at 31 March 2020 amounted to approximately HK\$1,255 million (approximately HK\$0.63 per share), representing an decrease of 4% from approximately HK\$1,313 million (approximately HK\$0.66 per share) as at 31 March 2019.

以下討論應與本公司截至二零二零年三月三十一日止年度之經審核綜合財務報表一併參閱。

表現

於回顧年度內，本集團作為總承建商，主要於香港從事樓宇建築及RMAA工程。於二零二零年三月三十一日，本集團手頭上大部分合約主要為與公營機構有關的工程。

於截至二零二零年三月三十一日止年度，本集團之綜合收入約為15.48億港元，較截至二零一九年三月三十一日止年度之約23.85億港元減少35%。截至二零二零年三月三十一日及二零一九年三月三十一日止年度，本公司母公司持有者應佔溢利分別約為0.24億港元及1.41億港元，減少83%。本年度之每股基本及攤薄盈利為1.20港仙（二零一九年：7.07港仙）。

溢利下跌主要由於(i)若干項目於二零二零年三月三十一日止年度仍處於初步發展階段及為防止COVID-19擴散而於二零二零年二月暫停部份地盤工作，因而導致收入有所下降；及(ii)萬順因董事會決定將其拆卸以重新發展有關地皮，因而產生一次性的終止確認的損失約0.41億港元。如撇除終止確認的損失，截至二零二零年三月三十一日止年度的本公司母公司持有者應佔溢利約為0.65億港元，較去年減少54%。

於二零二零年三月三十一日，母公司持有者應佔資產淨值約為12.55億港元（每股約0.63港元），較二零一九年三月三十一日之約13.13億港元（每股約0.66港元）減少4%。

DIVIDEND

The Board did not recommend the payment of any final dividend for the year ended 31 March 2020 (2019: HK4 cents per ordinary share).

BUSINESS REVIEW

Market review

With both short-term and long-term measures in housing strategies and healthcare infrastructure implemented by the HKSAR Government, the supply of the construction contracts from public sector will be still stable in the coming years. On the other hand, during the year of 2019/20, the social unrest in second half of 2019 and the political wrangling over funding at Legislative Council of the HKSAR affected the progress of the tendering and award of projects from public sector. The workload peaks and troughs for government projects became unpredictable.

The Group's performance

For the year ended 31 March 2020, the Group's revenue amounted to approximately HK\$1,548 million (2019: approximately HK\$2,385 million), representing a decrease of 35% from that of last year. The decrease in revenue was mainly resulted from certain projects were still in the preliminary stage of development during the current year while the projects in last year were in their mature stage of development. In addition, certain site works were suspended in February 2020 to prevent the spread of COVID-19 which affected the progress of the projects and revenue certified.

The gross profit margin increased from 9.9% for the year ended 31 March 2019 to 10.1% for the year ended 31 March 2020. Under the adoption of HKFRS 15, the gross profit margins of the Group's individual contract works will not remain constant but will fluctuate over different reporting periods, depending on the actual revenue certified and costs incurred for the construction work performed.

股息

董事會不建議就截至二零二零年三月三十一日止年度派發任何末期股息(二零一九年：每股普通股4港仙)。

業務回顧

市場狀況

鑒於香港特區政府對房屋及醫療硬件設施的短期及長期措施，公營項目的建築合約供應於往後年度將仍然穩定。另一方面，於二零一九至二零年度期間，二零一九年下半年的社會動盪及政治爭執令香港特區立法會在撥款問題出現阻攔，導致公共部門的項目招標和批出工程放緩，而令政府項目的工程量難以預測。

本集團表現

截至二零二零年三月三十一日止年度，本集團的收入約為15.48億港元(二零一九年：約23.85億港元)，較上年度減少35%。收入下跌主要由於若干項目於本年度仍處於初步發展階段，而去年的項目皆為已達發展成熟階段的工程。此外，部份地盤工作為防止COVID-19擴散而於二零二零年二月暫停，因而影響工程進度而減少收入確認。

毛利率由截至二零一九年三月三十一日止年度的9.9%上升至截至二零二零年三月三十一日止年度的10.1%。在採納香港財務報告準則第15號下，本集團個別合約工程的毛利率將不會保持穩定而是視乎已進行建築工程所產生之經核定實際收益及成本而於不同報告期間有所波動。

Building Construction Works

During the year ended 31 March 2020, the following substantial contract was awarded to the Group with contract value of approximately HK\$2,269 million:

- Construction of Public Housing Development at Tuen Mun Area 54 Sites 1 & 1A

Subsequent to the year ended 31 March 2020 and up to the date of this annual report, the Group was also secured the following substantial contract with estimated contract value of approximately HK\$2,762 million:

- Main Works for Development of Cingleot Premium Logistics Centre at Kwo Lo Wan of Hong Kong International Airport (*Note*)

Note: Project with a contract sum of HK\$5,638 million was awarded to Build King - Able Joint Venture, an unincorporated body which 49% interest of this joint operation is attributable to the Group.

We expect the above mentioned contracts will be substantially completed in two to four years from the project commencement.

On the other hand, the Group completed the following significant contracts regarding building construction works during the year ended 31 March 2020:

- Construction of Public Rental Housing Development at Lai Chi Kok Road – Tonkin Street Phase 1 & 2;
- Construction of Subsidised Sale Flats Development at Texaco Road; and
- Construction of Subsidised Sale Flats Development at Shatin Area 16, Wo Sheung Tun Street, Fo Tan and Footbridge Improvement Works at Siu Hong Road, Tuen Mun.

樓宇建築工程

於截至二零二零年三月三十一日止年度，本集團取得以下重大合約，其合約價值約為22.69億港元：

- 屯門第54區第1及1A號公共房屋發展計劃建築工程

於截至二零二零年三月三十一日止年度後至本年度報告之日期，本集團亦取得以下重大合約，其預計合約價值約為27.62億港元：

- 香港國際機場過路灣高端物流中心發展工程－主要工程(*附註*)

附註： 由利基-安保聯合體(並非屬法團的團體)投得之項目，合約總值56.38億港元，本集團佔該共同經營之49%權益。

我們預期，上述合約將於項目開始後兩至四年內大致完成。

另一方面，本集團於截至二零二零年三月三十一日止年度完成以下重大樓宇建築工程合約：

- 荔枝角道東京街第1及2期公共租住房屋發展計劃建築工程；
- 德士古道資助出售房屋發展計劃建築工程；及
- 沙田第16區火炭禾上墩街資助出售房屋發展計劃建築工程和屯門兆康路行人天橋改善工程。

Other Income and Gains

Other income and gains was approximately HK\$14 million for both of the year ended 31 March 2019 and 31 March 2020. For the year ended 31 March 2020, the interest income increased by HK\$5 million comparing with last year to approximately HK\$11 million as a result of the increase in fixed deposit and interest rate during the year. On the other hand, the rental income decreased by HK\$5 million comparing with last year to approximately HK\$2 million for the year ended 31 March 2020 as all the leases under Man Shung were terminated or expired during the year for the redevelopment plan of the Site.

Administrative Expenses

Administrative expenses increased from approximately HK\$81 million for the year ended 31 March 2019 to approximately HK\$90 million for the year ended 31 March 2020. The increase was mainly due to the increase in the consultancy fee incurred for the revitalisation of Man Shung in order to maximise its use.

Other Expenses

For the year ended 31 March 2020, the other expenses amounted to approximately HK\$41 million (2019: Nil), which representing the onetime loss on derecognition of the full remaining net book value of the building portion of Man Shung of approximately HK\$41 million following the decision of the Board to demolish it for the redevelopment of the Site.

Finance Costs

For the year ended 31 March 2020, the Group's finance costs amounted to approximately HK\$1.3 million (2019: approximately HK\$0.5 million). The interest for bank loans increased by HK\$0.4 million in this year due to the increase in trust receipt loans raised during the year comparing with last year. In addition, the interest on lease liabilities of approximately HK\$0.4 million (2019: Nil) was incurred during the year upon the adoption of HKFRS 16 in this year.

其他收入及收益

其他收入及收益於截至二零一九年三月三十一日及二零二零年三月三十一日止年度皆約為0.14億港元。截至二零二零年三月三十一日止年度，利息收入因定期存款和利率上升而較去年增加了0.05億港元至約0.11億港元；另一方面，因有關地皮的重新發展，有關萬順的所有租賃於年內終止或完結，導致租金收入較去年減少了0.05億港元至截至二零二零年三月三十一日止年度的約0.02億港元。

行政開支

行政開支由截至二零一九年三月三十一日止年度約0.81億港元增加至截至二零二零年三月三十一日止年度約0.90億港元。行政開支上升主要由於活化萬順以盡量提高其用途而產生的顧問費用。

其他開支

截至二零二零年三月三十一日止年度，其他開支約為0.41億港元(二零一九年：無)。董事會決定將萬順拆卸以重新發展有關地皮，其他開支乃萬順的樓宇部分的全數餘下賬面淨值約0.41億港元的一次性終止確認而產生的損失。

財務費用

截至二零二零年三月三十一日止年度，本集團的財務費用約為130萬港元(二零一九年：約50萬港元)。銀行貸款利息於本年度增加約40萬港元，原因是本年度提取的信託收據貸款較去年有所增加。此外，本年度因採納香港財務報告準則第16號而產生的租賃負債利息約為40萬港元(二零一九年：無)。

Share of Profits and Losses of Joint Ventures

For the year ended 31 March 2020, share of profits of joint ventures of approximately HK\$1 million (period from 1 December 2018 to 31 March 2019; profits of approximately HK\$2 million) was solely arisen from the share of net profits (including accounting adjustments in relation to acquisition) of Gold Victory Resources Inc. (“**Gold Victory**”) and its subsidiaries (collectively, the “**JV Group**”).

To expand the contract works business in the manufacturing, installation and trading of doors, door frames, furniture and other related products, Grand Superb Limited (“**Grand Superb**”, an indirect wholly-owned subsidiary of the Company) as the purchaser, acquired 50% interest in the Gold Victory from Golden Stone Asia Inc. (“**Golden Stone**”, a company controlled by Mr. WONG Kin Wah (“**Mr. WONG**”, an independent third party)) on 30 November 2018. To streamline the operation and manage the operational risk, the JV Group disposed its manufacturing arm in The People’s Republic of China (the “**PRC**”) at a gain in December 2019.

Pursuant to an equity transfer agreement (the “**Equity Transfer Agreement**”) entered into between Grand Superb, Golden Stone and Mr. WONG on 30 November 2018, Mr. WONG irrevocably warrants and guarantees to Grand Superb that the actual profits of the JV Group for the period commencing from 1 December 2018 and ending on 31 March 2022 (the “**Profit Warranty Period**”) shall not be less than the guaranteed profits (the “**Guaranteed Profits**”) of HK\$50 million (the “**Profit Warranty**”). In the event the total Guaranteed Profits are not achieved or reached for the entire Profit Warranty Period based on auditor’s certification, Golden Stone shall pay Grand Superb 50% of the shortfall between the actual profits and the Guaranteed Profits, unless the shortfall is caused by the event of force majeure as defined in the Equity Transfer Agreement. The Profit Warranty constitutes a derivative financial instrument of the Group.

應佔合營企業之損益

截至二零二零年三月三十一日止年度，應佔合營企業的溢利約0.01億港元(二零一八年十二月一日至二零一九年三月三十一日期間：溢利約0.02億港元)完全來自分佔Gold Victory Resources Inc. (「**Gold Victory**」)及其附屬公司(統稱「**合營集團**」)的淨溢利(包括收購相關的會計調整)。

為拓展合約工程業務至門、門框、傢俬及其他相關產品的生產、安裝及買賣，於二零一八年十一月三十日，Grand Superb Limited (「**Grand Superb**」，為本公司之一間間接全資附屬公司)作為買方，從Golden Stone Asia Inc. (「**Golden Stone**」，一間受控於黃建華先生(「**黃先生**」，為獨立第三方)的公司)購入Gold Victory的50%權益。於二零一九年十二月，合營集團為簡化營運和管理營運風險，將其位於中華人民共和國(「**中國**」)的生產部門出售並獲得收益。

根據Grand Superb、Golden Stone及黃先生於二零一八年十一月三十日訂立的一份股權轉讓協議(「**股權轉讓協議**」)，黃先生向Grand Superb作出不可撤銷保證及擔保，保證合營集團於二零一八年十二月一日起至二零二二年三月三十一日止期間(「**溢利保證期**」)的總實際溢利將不低於保證溢利(「**保證溢利**」)0.50億港元(「**溢利保證**」)。倘根據核數師核證，證實合營集團無法於溢利保證期取得或達到保證溢利的總額，Golden Stone須向Grand Superb支付實際溢利與保證溢利的差額之50%，除非有關差額乃由股權轉讓協議內所界定之不可抗力之事件所導致，則作別論。該溢利保證構成本集團的一項衍生金融工具。

Due to the impacts caused by the outbreak of COVID-19, the accumulated amount of profit that the JV Group recognised during the period from the acquisition date up to 31 March 2020 was lower than that previously estimated by approximately HK\$2 million. The Group will closely monitor the financial performance of the JV Group during the remaining Profit Warranty Period to ensure the Profit Warranty are met or remedy action has been taken according to the Equity Transfer Agreement.

Income Tax Expense

Income tax expense decreased by 46% from approximately HK\$29 million for the year ended 31 March 2019 to approximately HK\$16 million for the year ended 31 March 2020. The decrease was consistent with the decrease in taxable profit for this year.

Profit Attributable to Owners of the Parent

As a result of the foregoing, profit attributable to owners of the parent decreased by 83% from approximately HK\$141 million for the year ended 31 March 2019 to approximately HK\$24 million for the year ended 31 March 2020.

FINANCIAL REVIEW

Capital Structure, Liquidity and Financial Resources

The capital of the Group only comprises ordinary shares. The total equity of the Group as at 31 March 2020 was approximately HK\$1,255 million (31 March 2019: approximately HK\$1,313 million).

The Group monitors capital structure using a net gearing ratio, which is measured as total bank borrowings less cash and cash equivalents, divided by equity attributable to owners of the parent. As at 31 March 2020, the Group's net gearing ratio was 0 (31 March 2019: 0).

Due to the combined effects of (i) net cash outflows from operating activities; (ii) increase in restricted cash; (iii) net increase in bank borrowings; and (iv) payment of 2018/19 final dividend during the year, the Group's cash and cash equivalents recorded a decrease of 31% from approximately HK\$897 million as at 31 March 2019 to approximately HK\$617 million as at 31 March 2020. Current ratio of the Group stood at 1.8 at 31 March 2020, while that as at 31 March 2019 was 1.7. Current ratio is measured as total current assets divided by total current liabilities.

受COVID-19擴散的影響，合營集團於收購日期起至二零二零年三月三十一日止期間的累計利潤金額低於先前的預期金額約0.02億港元。本集團會密切監察合營集團於餘下溢利保證期的財務表現，以確保達成溢利保證或根據股權轉讓協議採取補救方案。

所得稅開支

所得稅開支由截至二零一九年三月三十一日止年度約0.29億港元，減少46%至截至二零二零年三月三十一日止年度約0.16億港元。跌幅與本年度之應課稅溢利的減少一致。

母公司持有者應佔溢利

由於上述因素，母公司持有者應佔溢利由截至二零一九年三月三十一日止年度約1.41億港元，減少83%至截至二零二零年三月三十一日止年度約0.24億港元。

財務回顧

資本架構、流動資金及財務資源

本集團的資本僅由普通股組成。本集團於二零二零年三月三十一日的權益總額約為12.55億港元（二零一九年三月三十一日：約13.13億港元）。

本集團根據淨槓桿比率來監察資本架構。淨槓桿比率以銀行借款總額減去現金及現金等值物，除以母公司持有者應佔權益計算。於二零二零年三月三十一日，本集團的淨槓桿比率為零（二零一九年三月三十一日：零）。

由於(i)經營業務產生的淨現金流出；(ii)受限制現金增加；(iii)銀行貸款淨增加；及(iv)年內支付二零一八至一九年度的末期股息的綜合影響，本集團之現金及現金等值物由於二零一九年三月三十一日約8.97億港元減少31%至於二零二零年三月三十一日約6.17億港元。本集團於二零二零年三月三十一日的流動比率為1.8，而於二零一九年三月三十一日則為1.7。流動比率以流動資產總值除以流動負債總值計量。

The Group's banking facilities, comprising primarily bank loans, overdrafts and performance bonds, amounted to approximately HK\$2,040 million as of 31 March 2020 (31 March 2019: approximately HK\$1,620 million), of which approximately HK\$1,717 million (31 March 2019: approximately HK\$1,341 million) was unutilised.

The Group maintains sufficient working capital resources to execute its contract works. The Group will continuously takes a prudent and cautious approach to cash application and its capital commitments.

Interest Exposure

At 31 March 2019 and 31 March 2020, the Group's bank borrowings were all denominated in Hong Kong dollars and on a floating rate basis. The Group's bank accounts were operated with principal bankers in Hong Kong. The interest rates of these bank accounts are determined by reference to the respective banks' offer rate. For the year ended 31 March 2019 and 31 March 2020, the Group did not engage in any interest rates and currency hedging or speculation activities.

Foreign Exchange Exposure

The Group's business operations are principally in Hong Kong, and certain operation of a joint venture was in the PRC during the year. Majority of the Group's business transactions are denominated in the local currencies. Hence, the Group is not exposed to significant foreign exchange risk.

Property, plant and equipment

The Group's property, plant and equipment amounted to approximately HK\$619 million as of 31 March 2020 (31 March 2019: approximately HK\$690 million). The decrease was mainly due to the derecognition of the full remaining net book value of the building portion of Man Shung of approximately HK\$41 million and the depreciation of right-of-use assets of approximately HK\$29 million provided during the year. The right-of-use assets recognised upon the adoption of HKFRS 16 were included in the "Property, plant and equipment".

本集團的銀行信貸主要包括銀行貸款、透支及履約擔保，於二零二零年三月三十一日的額度約為20.40億港元(於二零一九年三月三十一日：約16.20億港元)，其中約17.17億港元(於二零一九年三月三十一日：約13.41億港元)尚未動用。

本集團維持足夠的營運資金資源，以執行其合約工程。本集團對現金運用及資本承擔，將繼續持保守及審慎態度。

利率風險

於二零一九年三月三十一日及二零二零年三月三十一日，本集團的銀行貸款均以港元計值，並按浮動利率計算利息。本集團的銀行賬戶在香港主要銀行開設，相關銀行賬戶的利率由有關銀行拆放利率而釐定。於截至二零一九年三月三十一日及二零二零年三月三十一日止之年度內，本集團並無從事任何利率及貨幣對沖或投機活動。

外幣匯兌風險

本集團的業務經營主要位於香港，而一間合營企業的部份業務於年內則位於中國。本集團業務交易大多數以當地貨幣計值。因此，本集團並無面臨重大外幣匯兌風險。

物業、機器及設備

本集團的物業、機器及設備於二零二零年三月三十一日的金額約6.19億港元(於二零一九年三月三十一日：約6.90億港元)。減少主要由於年內終止確認萬順的樓宇部分的全數賬面淨值約0.41億港元及使用權資產的折舊約0.29億港元。因採納香港財務報告準則第16號而確認的使用權資產包括在「物業、機器及設備」內。

Accounts Receivable

The Group's accounts receivable represented the receivables for contract works in relation to completed and on-going contract works projects. Accounts receivable represents progress billing of work performed by us and the progress payment certificates issued by and received from our customers. The level of accounts receivable is principally affected by our work progress and the amount of the progress payment certificate received from our customers up to the end of the financial period. Approximately 93% of the accounts receivable as at 31 March 2020 was subsequently settled as at 10 June 2020 (31 March 2019: approximately 93% was subsequently settled by 31 May 2019).

Contract Assets

Balance at current year end mainly represented retention receivables of approximately HK\$168 million (31 March 2019: approximately HK\$162 million) and unbilled revenue of approximately HK\$51 million (31 March 2019: approximately HK\$58 million). Retention receivables represent the retention monies required by our customers to secure our Group's due performance of the contracts.

Other Payables and Accruals

As of 31 March 2020, the current and non-current balances of other payable and accruals amounted to approximately HK\$222 million (31 March 2019: approximately HK\$386 million) and HK\$7 million (31 March 2019: Nil), respectively, which mainly represented provision for contract works, staff costs payable and the lease liabilities recognised under HKFRS 16. Decrease in total balance of approximately HK\$157 million in current year end was the combined effects of the decrease in provision for contract works of approximately HK\$175 million and the recognition of lease liabilities of approximately HK\$17 million upon the adoption of HKFRS 16. The lease liabilities were included in "Other payables and accruals" in the consolidated statement of financial position.

應收賬款

本集團的應收賬款為有關已完成及在建合約工程項目的合約工程應收款。應收賬款為進行工程的進度款項及來自客戶發出及取得的階段付款證明書。應收賬款水平主要受於報告期末前的工程進度及截至財政年度止來自客戶取得的分階段付款證明書中的金額所影響。於二零二零年三月三十一日的應收賬款中，約93%已於其後於二零二零年六月十日或以前收回（於二零一九年三月三十一日：約93%已於二零一九年五月三十一日或以前收回）。

合約資產

本年度末餘額主要為應收保證金約1.68億港元（於二零一九年三月三十一日：約1.62億港元）及未發出付款證明書的收入約0.51億港元（於二零一九年三月三十一日：約0.58億港元）。應收保證金指客戶為確保本集團按合約如期完工所需的保留金。

其他應付款及應計費用

於二零二零年三月三十一日，其他應付款及應計費用的流動及非流動部份餘額分別約2.22億港元（於二零一九年三月三十一日：約3.86億港元）及0.07億港元（於二零一九年三月三十一日：無），其主要為合約工程的撥備、應付員工費用及按香港財務報告準則第16號確認的租賃負債。本年年末的總結餘減少約1.57億港元，主要由於合約工程的撥備下跌約1.75億港元及採納香港財務報告準則第16號而確認的租賃負債約0.17億港元的綜合影響。租賃負債於綜合財務狀況表中包括在「其他應付款及應計費用」內。

Charges on Assets

As at 31 March 2020, the accounts receivable, unbilled revenue and retention receivables related to certain contract works of HK\$130,653,000 (31 March 2019: HK\$21,963,000), HK\$43,824,000 (31 March 2019: HK\$23,255,000) and HK\$103,575,000 (31 March 2019: HK\$57,871,000), respectively were pledged in favour of certain banks to secure certain bank loans and banking facilities granted by those banks to the Group.

As at 31 March 2020, bank deposits amounting to HK\$110,000,000 (31 March 2019: Nil) were placed as guaranteed deposit for the performance bond issued by the relevant bank in relation to a construction project of the Group and the Group's bank loans with an aggregate carrying amounts of HK\$121,517,000 (31 March 2019: Nil) were secured by certain deposits accounts maintained with the relevant banks as continuing security for the obligations of the Group.

Contingent liabilities

Details of the Group's contingent liabilities are set out in note 30 to the financial statements.

Capital commitments

Details of the Group's capital commitments are set out in note 31 to the financial statements.

SIGNIFICANT INVESTMENT HELD AND FUTURE PLANS FOR MATERIAL INVESTMENTS ON CAPITAL ASSETS

The Group did not have any significant investment held as at 31 March 2020. The Group is currently investigating and evaluating different investment opportunities.

於二零二零年三月三十一日，銀行存款總值110,000,000港元(於二零一九年三月三十一日：無)存放於相關銀行作為該銀行就本集團一項建築工程項目開出的履約保證金的保證存款及本集團的銀行貸款總值121,517,000港元(於二零一九年三月三十一日：無)以本集團於相關銀行持有的若干存款戶口作為本集團的責任的持續抵押品。

MATERIAL ACQUISITION AND DISPOSALS

Possible Acquisition

As disclosed in the joint announcement of the Company and Vantage International (Holdings) Limited (“Vantage”, stock code: 15, an intermediate holding company of the Company) dated 9 July 2019, Rhythm Classic Limited (the “Purchaser”, an indirect wholly-owned subsidiary of the Company) entered into a framework agreement on 9 July 2019 (the “Framework Agreement”) with an independent third party (“Vendor”) for the possible acquisition of 100% of the equity interest of a Hong Kong company (the “Target Company”) and 100% of the interest-free shareholder loan (if any) advanced by the Vendor to the Target Company at a consideration of HK\$130 million (the “Possible Acquisition”). Pursuant to the Framework Agreement, the Possible Acquisition is conditional upon, among others, the fulfilment of the conditions as stated in the Framework Agreement (the “Conditions Precedent”) within 180 days from the date of signing of the Framework Agreement, or such other period as duly agreed by both parties in writing (the “Agreement Valid Period”).

Further disclosed in the joint announcement of the Company and Vantage dated 2 January 2020, given that additional time was required for the fulfilment of the Conditions Precedent, the Purchaser and the Vendor have entered into a supplementary agreement on 2 January 2020, to extend the Agreement Valid Period to 2 July 2020 (or such other period as duly agreed by both parties in writing).

Up to the date of this annual report, the Conditions Precedent have not been fulfilled and no deposit has been paid to the Vendor. The Possible Acquisition is subject to, among others, fulfilment of the Conditions Precedent and the entering into of a formal agreement (the “Formal Agreement”). The Possible Acquisition is also subject to fulfilment of such conditions precedent as may be provided under the Formal Agreement, which terms and conditions are yet to be finalised. The Framework Agreement may or may not lead to the entering into the Formal Agreement, and thus, the Possible Acquisition may or may not proceed. If proceed, it is expected that the Possible Acquisition will constitute a discloseable transaction to the Company under Chapter 14 of the Rules (the “Listing Rules”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“The Stock Exchange”). Further announcement(s) in relation to the Possible Acquisition will be made by the Company as and when appropriate in accordance with the Listing Rules.

誠如本公司與盈信控股有限公司(「盈信」, 股份代號: 15, 本公司的一間中間控股公司)於日期為二零一九年七月九日的聯合公告所披露, Rhythm Classic Limited(「買方」, 本公司的一間間接全資附屬公司)與一獨立第三方(「賣方」)於二零一九年七月九日就可能收購一間香港公司(「目標公司」)的100%股本權益及賣方向該目標公司提供的100%免息股東貸款(如有)之事項訂立框架協議(「框架協議」), 代價為1.30億港元(「可能收購事項」)。根據框架協議, 可能收購事項須待(其中包括)達成框架協議所列條件(「先決條件」)後方可作實, 而達成先決條件限期為框架協議簽署日期起180天內(或雙方經書面協定之其他日期)(「協議有效期」)。

本公司與盈信於日期為二零二零年一月二日的聯合公告進一步披露, 由於需要更多時間達成先決條件, 買方與賣方於二零二零年一月二日訂立一份補充協議, 以延長協議有效期至二零二零年七月二日(或雙方經書面協定之其他日期)。

截至本年度報告之日期, 先決條件仍未獲達成及並無支付保證金予賣方。可能收購事項須待(其中包括)先決條件獲達成及訂立正式協議(「正式協議」)後方可作實。可能收購事項亦受限於正式協議中可能規定的先決條件的達成, 而有關協議之條款及條件尚未落實。框架協議可能會或可能不會導致簽訂正式協議。因此, 可能收購事項可能會或可能不會進行。如進行可能收購事項, 預期該交易將根據香港聯合交易所有限公司(「聯交所」)證券上市規則(「上市規則」)第十四章構成本公司的一項須予披露交易。本公司將適時根據上市規則就可能收購事項刊發進一步公告。

USE OF PROCEEDS FROM THE LISTING

The shares of the Company (the “Share(s)”) were listed (the “Listing”) on the Main Board of The Stock Exchange on 20 February 2017. Net proceeds from the Listing were approximately HK\$524 million (after deducting the underwriting commission and other expenses in relation to the 500,000,000 new ordinary shares issued pursuant to the listing of Shares on The Stock Exchange. As at 31 March 2020, the unused net proceeds were approximately HK\$82 million (31 March 2019: approximately HK\$181 million). The unused proceeds were deposited in licensed banks in Hong Kong.

According to the section “Future Plans and Proposed Use of Proceeds” as set out in the prospectus of the Company dated 26 January 2017 (the “Prospectus”), the Group used the net proceeds during the year ended 31 March 2020 as follows:

EMPLOYEES AND REMUNERATION POLICY

As of 31 March 2020, the Group employed 336 full-time employees (31 March 2019: 360) in Hong Kong. The Group remunerates its employees based on their performance and work experience and with reference to the prevailing market conditions. On top of the regular remuneration, discretionary bonus and share options may be granted to senior management and staff members by reference to the Group's performance, specific project's performance as well as the individual employee's performance. Staff benefits include mandatory provident fund, medical insurance, incentive travel, subsidies for education and training programmes.

At the Annual General Meeting ("AGM") of the Company held on 31 August 2018, the adoption of a share option scheme (the "Option Scheme") was considered and approved. The purposes of the Option Scheme are to provide incentives for the directors and full-time employees of the members of the Group to work towards enhancing the value of the Company and its Shares for benefit of the Company and its shareholders as a whole. The Option Scheme provides the Group with a flexible means of either retaining, incentivising, rewarding, remunerating, compensating and/or providing benefits to participants of the scheme. From the date of adoption of the Option Scheme and up to 31 March 2020, the Company did not grant any share options under the Option Scheme and no equity-settled share option expense was charged to the profit or loss.

THE BOARD

The INEDs

During the year ended 31 March 2020, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three INEDs, with at least one INED possessing appropriate professional qualifications, or accounting or related financial management expertise as required by Rules 3.10(1) and 3.10(2) of the Listing Rules. The Company has also met the requirement of at least one-third of members of the Board being INEDs as required by Rules 3.10A of the Listing Rules.

The three INEDs of the Company are persons of high caliber, with professional qualifications and experience in the fields of engineering, education and accounting and finance. With their experience gained from various sectors, they provide strong support towards the effective discharge of the duties and responsibilities of the Board.

The INEDs are appointed for a fixed specific term. Each of Dr. LI, Ms. MAK, Ms. LEUNG, all being INEDs, has made an annual confirmations of independence pursuant to Rule 3.13 of the Listing Rules. The Company has assessed the independence and considers all of the INEDs to be independent based on the independence guidelines set out in Rule 3.13 of the Listing Rules, their non-involvement in the daily operation and management of the Group and the absence of any relationships which will interfere with the exercise of their independent judgment.

The Company confirms that year of service of all INEDs is less than 9 years.

Meetings

Regular Board meetings are held at least four times a year at approximately quarterly intervals. Tentative dates of regular Board meetings for next year are scheduled approaching the end of each calendar year in order to facilitate the Directors to plan for attendance of the meetings. Meetings will also be convened, as and when required, to deal with ad hoc issues.

Any Director who is not able to present physically may participate at any Board meeting through electronic means of communication, such as conference telephone or other similar communication equipment, in accordance with the Articles of Association of the Company (the “Articles”).

Notice convening each regular Board meeting is sent at least 14 days in advance, and reasonable notice is given for other Board meetings. The Company Secretary assists the Chairman of the Board to prepare the meeting notice and agenda. Each Director may include any item in the agenda. The agenda, accompanied by meeting papers with sufficient and reliable information, are sent to each Director not less than 7 days before the date of a Board meeting to enable the Directors to make informed decisions on the matters to be discussed, except where a Board meeting is convened on a very urgent basis to consider any urgent ad hoc matter.

Minutes of Board meetings are recorded in sufficient details regarding the matters considered by the Board at the meeting and decisions reached. Draft minutes of Board meetings are circulated to the Directors for comments and the signed minutes are kept by the Company Secretary and open for inspection to any Director on request.

Appointment, Re-election and Removal of Directors

The Board is responsible for reviewing the Board composition, developing and formulating the relevant procedures for nomination and appointment of Directors, monitoring the appointment and succession of Directors and assessing the independence of INEDs. The appointment of INEDs adheres to the guidelines for assessing independence as set out in Rule 3.13 of the Listing Rules. The Board, through the Nomination Committee set up in January 2017, reviews from time to time its own structure, size and composition to ensure that it has a balance of appropriate expertise, skills and experience for the needs of the businesses of the Group.

The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. The Board adopted a board diversity policy (the “**Board Diversity Policy**”) in January 2017 to set out the approach to achieve diversity of Board members. In 2019, the Board also adopted a director nomination policy (the “**Director Nomination Policy**”) upon the recommendation of the Nomination Committee which set out the approach and procedures the Board adopts for the nomination and selection of Directors. A summary of each of the policies is set out in the subsection “Nomination Committee” under the section “BOARD COMMITTEES” in this report.

The term of office of each of the Directors has been fixed for a specific term for not more than three years. The Directors are subject to retirement by rotation and re-election at the AGM in accordance with the Articles.

In accordance with the Articles, at least one-third of the Directors for the time being (or, if their number is not a multiple of three, then the number nearest to but not less than one-third) shall retire from office by rotation. A retired Director shall be eligible for re-election and reappointment at each annual general meeting provided that each Director shall be subject to retirement by rotation at least once every three years. The election of each candidate is done through a separate resolution. Any new Director appointed during the year as an addition to the Board or to fill a casual vacancy on the Board shall hold office only until the next coming general meeting of the Company and shall then be subject to re-election at that meeting.

In accordance with the Article, Mr. CHEUNG, Mr. IP and Ms. LEUNG shall retire from office at the forthcoming AGM to be held on 4 September 2020 (the “2020 AGM”). All the above retiring Directors, being eligible, have offered themselves for re-election to serve for another terms at the 2020 AGM. Details with respect to the candidates standing for election as Directors are set out in the AGM circular to Shareholders.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

During the year ended 31 March 2020, Mr. NGAI served as the Chairman of the Board and Mr. IP or Mr. CHEUNG served as the Chief Executive Officer (“CEO”) of the Company. This segregation ensures a clear division of the Chairman’s responsibilities for the management of the Board and the CEO’s responsibilities for the day-to-day management of the Company’s business.

The Chairman is responsible for providing leadership for the Board, and ensuring that all Directors are properly briefed on issues arising at Board meetings and that the Directors receive adequate, complete and reliable information in a timely manner. The Chairman has an additional or casting vote in the event of an equality of votes on any matter to be decided by the Board.

The CEO is appointed by the Board and is responsible for providing leadership for the management, implementing and reporting to the Board on the Group’s strategy, overseeing the day-to-day operations of the Group and providing all such information to the Board as is necessary to enable the Board to monitor the performance of the management.

According to the then enacted code provision A.2.7 of the CG Code, the Chairman met with the INEDs of the Company for once without the presence of the management and the other Executive Directors on 27 November 2019.

The Board has set up three Board Committees, namely, the Audit Committee, the Remuneration Committee and the Nomination Committee, to oversee particular aspects of the Company's affairs.

Audit Committee

The Company's Audit Committee was established on 18 January 2017 with specific written terms of reference stipulating its authorities and duties, which are available on the websites of the Company and The Stock Exchange.

As at 31 March 2020, the Audit Committee comprised three INEDs, namely Dr. LI, Ms. MAK and Ms. LEUNG. Ms. LEUNG is currently the chairman of the Audit Committee. Ms. LEUNG possesses the appropriate accounting qualifications and experiences in financial matters.

The main responsibilities of the Audit Committee are to review the consolidated financial statements and the auditor's report, and to monitor the integrity of the consolidated financial statements. It also assists the Board to oversee risk management and internal control systems and internal and external audit functions.

The Audit Committee holds regular meetings at least twice a year and they also meet with the Company's external auditor at least twice a year to discuss the audit plan and to review the Company's reports and accounts. During the year ended 31 March 2020, the Audit Committee held five meetings and the primarily works performed by the Audit Committee were, among others:

- reviewed the unaudited accounts, interim report and interim results announcement of the Company and the Group;
- reviewed the audited accounts and final results announcement of the Company and the Group;
- reviewed the accounting policies and practices adopted by the Company and the Group;
- reviewed and recommend the appointment, reappointment and removal of external auditor;
- approved the scope and plan of internal and external audit;
- reviewed the engagement, services (including non-audit services) provided and remuneration of the external auditor and its independence;
- reviewed the results and effectiveness of the internal and external audit function;
- reviewed and monitored the adequacy and effectiveness of the financial reporting function, risk management system and internal control system of the Group;
- reviewed the continuing connected transactions;
- reviewed the "Policy for Non-audit Services provided by the Group's External Auditor and its Associates" and monitored the policy's implementation; and
- reviewed the terms of reference of the Audit Committee.

It is confirmed that there is no disagreement between the Board and the Audit Committee's view on re-appointment of external auditor, and they both have agreed to recommend the re-appointment of Ernst & Young as the Company's external auditor for the ensuing year at the 2020 AGM of the Company.

DIVIDEND POLICY

To enhance transparency of the Company in the recommendation and declaration of dividend, the Board has adopted a written “Dividend Policy” which sets out the factors of determining the recommendation and declaration of dividend since 18 March 2019.

Under the “Dividend Policy”, the Board may consider declaring and paying dividends to the Shareholders out of the Company’s distributable reserves. Such declaration and payment of dividends shall remain to be determined at the sole discretion of the Board, subject to the requirements of all applicable laws and the Articles.

Pursuant to the “Dividend Policy”, the Board shall strike a balance between providing immediate return to the Shareholders through the payment of dividends whilst retaining adequate reserves as the Group’s working capital and for the Group’s future growth. In deciding whether to propose or declare a dividend and in determining the dividend amount and means of payment, the Board shall take into account, among others:

- the actual and expected financial performance of the Group;
- the Group’s liquidity position;
- the capital and debt level of the Group;
- retained earnings and distributable reserves of the Company and major subsidiaries of the Group; and
- the working capital requirements, capital expenditure requirements and future development plans of the Group.

The Board will from time to time review the Dividend Policy and may exercise at its absolute and sole discretion to update, amend and/or modify the Dividend Policy at any time as the Board deems fit and necessary.

AUDITOR'S REMUNERATION

Ernst & Young was re-appointed by the Shareholders of the Company at the AGM held on 28 August 2019 as the Company's external auditor until the conclusion of the forthcoming AGM.

During the year, the Company also awarded non-audit services works to Ernst & Young and its associates. Through the Audit Committee, the Board monitors the non-audit services performed by its external auditor and its associates to the Group to ensure that the independence and objectivity of the external auditor would not be impaired.

Pursuant to the "Policy for Non-audit Services provided by the Group's External Auditor and its Associates", all proposed non-audit services of the external auditor or its associates would be reviewed by the Audit Committee before the respective engagement. During the year ended 31 March 2020, the Audit Committee reviewed the nature of non-audit services proposed to be performed by Ernst & Young and/or its associates and confirmed that the non-audit services did not give rise to impairment of actual or perceived independence, or objectivity of the audit work itself. RISK MANAGEMENT AND INTERNAL CONTROL

The Board recognises its overall responsibility for maintaining a sound and effective system of risk management and internal control to safeguard the Shareholders' investment and the Company's assets, ensure the maintenance of proper accounting records and the truth and fairness of the financial statements and ensure compliance with relevant legislation and regulations. The systems are designed to provide reasonable, but not absolute, assurance against material errors, losses and fraud, and manage rather than eliminate risks of failure in the Group's operational systems and in the achievement of the Group's business objectives.

The Board has entrusted the Audit Committee with the responsibility to review the risk management and internal control systems of the Group, covering all the departments and business units to monitor, assess and manage various risks in the Group's business activities.

During the year, the Group's internal auditor conducted systematic reviews of the Group's internal control system by adopting a risk-based approach and review the effectiveness of the Group's internal control system according to an internal audit plan approved by the Audit Committee. The CEO and any members of the Audit Committee may instruct the internal auditor to undertake internal audit activities of an urgent or sensitive nature. The internal auditor reports directly to the Audit Committee and has free access to review all aspects of the Group's activities and systems. Internal audit findings and control weaknesses, respective management's response and follow-up plans/actions taken have been summarised and reported to the Audit Committee at least annually. Other Directors are also informed of the findings and weakness identified.

COMMUNICATIONS WITH SHAREHOLDERS AND INVESTORS

The Company is endeavouring to maintain a high level of transparency in communication with Shareholders and investors in general. The Company has adopted a “Shareholders’ Communication Policy” on 18 January 2017, which is available on the website of the Company, reflecting mostly the current practices of the Company for the communication with its Shareholders. The various channels via which the Company communicates with its Shareholders include interim and annual reports, information on The Stock Exchange’s and the Company’s websites, and general meetings.

The Company’s AGM provides an opportunity for Shareholders to communicate face to face with the Directors about the Group’s performance and operations. The Directors are pleased to present their report together with the audited consolidated financial statements of the Group for the year ended 31 March 2020.

PRINCIPAL ACTIVITIES

The principal activities of the Company are investment holding and the provision of corporate management services. Details of the principal activities of the Group's principal subsidiaries are set out in note 1 to the financial statements. There were no significant changes in the nature of the Group's principal activities during the year.

BUSINESS REVIEW

A review of the business of the Group during the year, an analysis of the Group's financial performance during the year using financial key performance indicators, a discussion on the Group's future business development and a description of the principal risks and uncertainties facing by the Group are provided in this report and the "MANAGEMENT DISCUSSION AND ANALYSIS" section of this annual report on pages 13 to 24. Also, the Group's financial risk management objectives and policies are set out in note 35 to the financial statements.

The Group is committed to be an environmental-responsible corporation with the aim to conserve the environment while making reasonable returns. The Group has operated an environmental management system which complies with international standards and will continuously encourage our business partners, suppliers and sub-contractors to follow the same standards. Further information of the Group's policies and performance during the year ended 31 March 2020 about the environment would be included in the "Environmental, Social and Governance Report" of the Company to be published within three months from the date of this annual report. During the year ended 31 March 2020, there was no material breach of or non-compliance with applicable laws and regulations by the Group that have significant impact on the business and operations of the Group.

Business and Market Risk

Demand for services and products of the Group is cyclical in nature and directly correlates with the level of real estate development, construction activities, liquidity demands and general economic environment in Hong Kong. The Group relies heavily on public sector projects which by their nature are only awarded by a limited number of customers who are normally the HKSAR Government and/or various institutional bodies. There is no guarantee that our customers will provide the Group with new business or that we will secure new customers.

The Group's business and profitability may be materially and adversely affected by failure to tender for new contract works, any material reduction in spending by the HKSAR Government or various institutional bodies on public sector works and/or delay in awarding contracts of such works. The Group has accumulated over 40 years' experience in construction industry, we will continue to keep a close eye on project safety, project quality and project efficiency to ensure we remain competitive in tendering new projects.

Construction risk

The Group is exposed to construction risk in relation to price fluctuation, duration of works, quality of work, environmental protection and safety involved in the construction business, which may adversely affect the Group's profitability. The Group tries to manage and mitigate these risks through risk transfer, improve communication between project teams with project estimation and procurement department and implementation of management system which meets international standards.

業務和市場風險

本集團的服務和產品需求屬週期性質，並與香港的房地產開發、建設活動、資金流動性需求和總體經濟環境水平直接相關。本集團主要倚賴公營項目，其特性為只透過數目有限並一般為香港特區政府及／或各機構組織的客戶取得項目。本集團無法保證客戶將給予我們新的業務，或我們將取得新客戶。

如未能成功投標取得新合約工程、香港特區政府或其他機構組織大幅削減公營工程開支及／或延遲批出工程合約，均可能對本集團的業務及盈利能力造成重大不利影響。本集團在建築業積累超過40多年的經驗，我們將繼續密切留意項目安全，項目質量和項目效率，以確保我們在投標新項目方面保持競爭力。

施工風險

本集團面臨有關價格波動、工程時間、施工質量、環保及安全等與建築業務相關的施工風險，或會對本集團的盈利能力造成不利影響。本集團通過風險轉移、加強施工隊伍與項目評估及採購部門之間的溝通，以及實施符合國際標準的管理系統等措施來管理及減輕這些風險。

Compliance Risk

The Group is exposed to compliance risk in relation to various rules and regulations, including but not limited to rules and regulations in relation to construction labour, occupational health and safety, environmental protection, contractor registration and listing in Hong Kong. Non-compliance may cause serious legal sanctions, material financial loss, or loss to reputation and loss of business to the Group. The Group paid high attention to the enactment and amendment of laws and regulations which may cause legal or business risks to the Group's business and will arrange appropriate training and experience sharing activities for relevant employees. The Group also launched a safety promotion campaign "Safety • My Habit" since 2017 to promote safety awareness and continuously invest in the provision of appropriate self-owned safety tools to sub-contractors or suppliers in high risk operation.

Risk on Reliance of Key Management Personnel

The Group's success and growth depends on our ability to identify, hire, train and retain suitable, skilled and qualified employees, including management personnel with the requisite industry expertise. The Directors and members of senior management, in particular, the Executive Directors, are important to the Group. If any of the Executive Directors cease to be involved in the management of the Group and the Group is unable to find suitable replacements in a timely manner, there could be an adverse impact on our business, results of operation and profitability of the Group.

Business Partners Risk

The Group relies on third-party sub-contractors and service providers in certain parts of its business. The management realises that such operational dependency may pose a threat of vulnerability to unexpected poor or lapses in service including reputation damage, business disruption and monetary losses. In addition, some of the Group's businesses are conducted through joint ventures/joint operations in which the Group shares control and risks with other business partners. The relevant risks include that these business partners may not continue their relationships with the Group, do not work for the Group's interest, take actions against the Group's interest, undergo a change of control or not fulfil their obligations under the joint ventures/joint operations. To address such uncertainties, the Group only engages/cooperates with reputable and experienced business partners and closely monitors their performance.

合規風險

依賴主要管理人員的風險

本集團的成功與發展取決於我們物色、聘用、培訓及挽留適當、熟練及合資格僱員的能力，包括具備所需行業專業知識的管理人員。董事及高級管理層成員（尤其是執行董事）對我們非常重要。若任何該等執行董事日後不再參與管理本集團，而本集團未能及時覓得適當替代人選，則可能對本集團的業務、經營業績及盈利能力造成不利影響。

業務夥伴風險

本集團依賴第三方分判商及服務供應商提供若幹部分的業務。管理層清楚該等營運依賴性或會令本集團在服務突然轉差或出現真空期時，容易受到不利影響，包括聲譽受損、業務中斷及金錢損失。此外，本集團部分業務以合營企業／共同經營進行，與其他業務夥伴分擔控制和風險。相關風險包括：該等業務夥伴或未能與本集團維持其合作關係、不以本集團利益而行事、向本集團採取不利行動、控制權變更或未能履行其於合營企業／共同經營安排的責任等。針對有關不明朗因素，本集團僅會聘請或與信譽良好及富經驗之業務夥伴合作，並會密切監察其表現。

Cyber and Information Security Risk

Frequency of cyber-attacks like sophisticated phishing campaigns and ransomware continued increased in recent years. The potential threat of a cyber-attack is increasing. Cyber-attacks may lead to loss of information, leakage of confidential information, unavailability of systems and disruption of operation that significant costs may be incurred for data recovery and system restoration, and/or possible claims. The Group manages this risk by implement security measures such as firewall, anti-spam and anti-virus protection, and increase internal communication of cyber and information security threats to raise staff awareness.

SUMMARY FINANCIAL INFORMATION

A summary of the published results and the statements of financial position of the Group for the last five financial years, as extracted from the audited consolidated financial statements and the Prospectus of the Company dated 26 January 2017, is set out on pages 4 to 5 of this annual report. 1. CORPORATE AND GROUP INFORMATION

Able Engineering Holdings Limited (the “**Company**”) is a limited liability company incorporated in the Cayman Islands and its shares are publicly traded on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). The registered office of the Company is located at PO Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands. The principal place of business of the Company is located at No. 155 Waterloo Road, Kowloon Tong, Kowloon, Hong Kong.

During the year, the Company and its subsidiaries (collectively referred to as the “**Group**”) were principally engaged in building construction and repair, maintenance, alteration and addition (“**RMAA**”) works.

In the opinion of the directors of the Company (the “**Directors**”), Profit Chain Investments Limited (“**Profit Chain**”), a company incorporated in the British Virgin Islands (“**BVI**”), is the immediate holding company of the Company; Vantage International (Holdings) Limited (“**Vantage**”), a company incorporated in Bermuda and listed on the Main Board of the Stock Exchange, is the intermediate holding company of the Company; and the ultimate holding company of the Company is Winhale Ltd., a company incorporated in the BVI.

For the purposes of these financial statements, the Company and its subsidiaries are hereinafter collectively referred to as the “**Group**”; whereas Vantage and its subsidiaries, but excluding the Group, are collectively referred to as the “**Remaining Vantage Group**”.

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention, except for a derivative financial instrument which has been measured at fair value, and are presented in Hong Kong dollars (“HK\$”) and all values are rounded to the nearest thousand (“HK\$’000”) except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 March 2020. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

2.1 編製基準

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

HKFRS 16 replaces HKAS 17 *Leases*, HK(IFRIC)-Int 4 *Determining whether an Arrangement contains a Lease*, HK(SIC)-Int 15 *Operating Leases – Incentives* and HK(SIC)-Int 27 *Evaluating the Substance of Transactions Involving the Legal Form of a Lease*. The standard sets out the principles for the recognition, measurement, presentation and disclosure of leases and requires lessees to account for all leases under a single on-balance sheet model to recognise and measure right-of-use assets and lease liabilities, except for certain recognition exemptions. Lessor accounting under HKFRS 16 is substantially unchanged from HKAS 17. Lessors continue to classify leases as either operating or finance leases using similar principles as in HKAS 17. Accordingly, HKFRS 16 did not have any significant impact on leases where the Group is the lessor.

The Group has adopted HKFRS 16 using the modified retrospective method with the date of initial application of 1 April 2019. Under this method, the standard has been applied retrospectively with no impact to the opening balance of retained profits at 1 April 2019, and the comparative information for 2019 was not restated and continued to be reported under HKAS 17 and related interpretations.

New definition of a lease

Under HKFRS 16, a contract is, or contains, a lease if the contract conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to obtain substantially all of the economic benefits from use of the identified asset and the right to direct the use of the identified asset. The Group elected to use the transition practical expedient allowing the standard to be applied only to contracts that were previously identified as leases applying HKAS 17 and HK(IFRIC)-Int 4 at the date of initial application. Contracts that were not identified as leases under HKAS 17 and HK(IFRIC)-Int 4 were not reassessed. Therefore, the definition of a lease under HKFRS 16 has been applied only to contracts entered into or changed on or after 1 April 2019.

香港財務報告準則第16號取代香港會計準則第17號租賃、香港(國際財務報告詮釋委員會) – 詮釋第4號釐定安排是否包括租賃、香港(準則詮釋委員會) – 詮釋第15號經營租賃 – 優惠及香港(準則詮釋委員會) – 詮釋第27號評估涉及租賃法律形式交易的內容。該準則載列了與租賃有關的確認、計量、呈列及披露的原則，並要求承租人按單一資產負債表模型將所有租賃入賬，以確認及計量使用權資產及租賃負債，惟若干確認豁免除外。香港財務報告準則第16號大致沿用香港會計準則第17號內出租人的會計處理方式。出租人將繼續使用與香港會計準則第17號類似的原則將租賃分類為經營租賃或融資租賃。因此，香港財務報告準則第16號對本集團為出租人的租賃並無重大影響。

本集團於二零一九年四月一日按修正追溯調整法首次採用香港財務報告準則第16號，根據此方法，本集團已追溯應用該準則，並不影響於二零一九年四月一日之留存收益期初餘額，且概不會重列二零一九年的比較資料，而是繼續根據香港會計準則第17號及有關詮釋作出報告。

Nature of the effect of adoption of HKFRS 16

The Group has lease contracts for leasehold land, office properties and machinery. As a lessee, the Group previously classified leases as either finance leases or operating leases based on the assessment of whether the lease transferred substantially all the rewards and risks of ownership of assets to the Group. Under HKFRS 16, the Group applies a single approach to recognise and measure right-of-use assets and lease liabilities for all leases, except for an elective exemptions for leases of low value assets (elected on a lease by lease basis) and leases with a lease term of 12 months or less (“short-term leases”) (elected by class of underlying asset). Instead of recognising rental expenses under operating leases on a straight-line basis over the lease term commencing from 1 April 2019, the Group recognises depreciation (and impairment, if any) of the right-of-use assets and interest accrued on the outstanding lease liabilities (as finance costs).

Impact on transition

Lease liabilities at 1 April 2019 were recognised based on the present value of the remaining lease payments, discounted using the incremental borrowing rate at 1 April 2019 and included in other payables and accruals. The right-of-use assets were measured at the amount of the lease liability, adjusted by the amount of any prepaid or accrued lease payments relating to the lease recognised in the statement of financial position immediately before 1 April 2019.

All these assets were assessed for any impairment based on HKAS 36 on that date and the Group elected to present right-of-use assets as part of the elements of property, plant and equipment in the statement of financial position.

The right-of use assets also include the leasehold land recognised previously under finance leases of HK\$644,909,000 that was reclassified from land and buildings at 1 April 2019.

The Group has applied the short-term lease exemption to leases with a lease term that ends within 12 months from the date of initial application when applying HKFRS 16 at 1 April 2019.

本集團擁有租賃土地、辦公室物業及機械等的租賃合約。本集團作為承租人根據租賃是否將資產擁有權相關的幾乎所有回報與風險轉移給本集團，將租賃分類為融資租賃或經營租賃。根據香港財務報告準則第16號，本集團採用單一方法確認及計量所有租賃的使用權資產及租賃負債，惟低價值資產租賃(按逐項租賃基準選擇)及租期為或少於12個月的租賃(「短期租賃」)(按相關資產類別選擇)的一項選擇性豁免除外。自二零一九年四月一日開始的租期內，本集團並無按直線法確認經營租賃項的租金開支，而確認了使用權資產的折舊(及減值，如有)以及未償還租賃負債的應計利息(作為財務費用)。

過渡影響

於二零一九年四月一日之租賃負債按剩餘租賃款項的現值確認，折現率採用二零一九年四月一日的增量借貸利率，計入其他應付款及應計費用。使用權資產根據租賃負債金額計量，並根據二零一九年四月一日前的財務狀況表所確認租賃相關的任何預付或累計租賃款項金額作出調整。

所有該等資產於該日均根據香港會計準則第36號進行減值測試。本集團選擇於財務狀況表中將使用權資產作為物業、機器及設備之一部分呈列。

使用權資產亦包括過往確認為融資租賃並於二零一九年四月一日由土地及樓宇重新分類的租賃土地644,909,000港元。

本集團於二零一九年四月一日應用香港財務報告準則第16號時，將短期租賃豁免應用於租期自首次應用日期起十二個月內終止的租賃。

HK(IFRIC)-Int 23 addresses the accounting for income taxes (current and deferred) when tax treatments involve uncertainty that affects the application of HKAS 12 (often referred to as “**uncertain tax positions**”). The interpretation does not apply to taxes or levies outside the scope of HKAS 12, nor does it specifically include requirements relating to interest and penalties associated with uncertain tax treatments. The interpretation specifically addresses (i) whether an entity considers uncertain tax treatments separately; (ii) the assumptions an entity makes about the examination of tax treatments by taxation authorities; (iii) how an entity determines taxable profits or tax losses, tax bases, unused tax losses, unused tax credits and tax rates; and (iv) how an entity considers changes in facts and circumstances. Upon adoption of the interpretation, the Group considered whether it has any uncertain tax positions arising from the transfer pricing on its intergroup transactions. Based on the Group’s tax compliance and transfer pricing study, the Group determined that it is probable that its transfer pricing policy will be accepted by the tax authority. Accordingly, the interpretation did not have any impact on the financial position or performance of the Group.

Further information about those HKFRSs that are expected to be applicable to the Group is described below:

Amendments to HKFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group expects to adopt the amendments prospectively from 1 April 2020. Since the amendments apply prospectively to transactions or other events that occur on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKAS 1 and HKAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information. A misstatement of information is material if it could reasonably be expected to influence decisions made by the primary users. The Group expects to adopt the amendments prospectively from 1 April 2020. The amendments are not expected to have any significant impact on the Group's financial statements.

Investments in joint ventures

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of joint ventures are included in the consolidated statement of profit or loss and other comprehensive income. In addition, when there has been a change recognised directly in the equity of the joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its joint ventures are eliminated to the extent of the Group's investments in the joint venture, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of joint ventures is included as part of the Group's investments in joint ventures.

If an investment in a joint venture becomes an investment in an associate, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of the joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the joint venture upon loss of joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

合營企業是一種共同安排，共同控制安排的各方有權分享合營企業的資產淨值。共同控制指按照合約協定對某項安排所共有的控制，僅在相關活動要求共同享有控制權的各方作出一致同意的決定時存在。

本集團於合營企業的投資採用權益會計法按本集團應佔資產淨值減任何減值虧損於綜合財務狀況表中列賬。任何可能存在的不同會計政策已作出調整以使其一致。本集團應佔合營企業收購後業績及其他全面收入於綜合損益及其他全面收入表中列賬。此外，倘存在直接於合營企業權益確認的變動，則本集團於綜合權益變動表確認其所佔任何變動（倘適用）。本集團及其合營企業之間的交易所導致的未變現收益及虧損，均按本集團所佔合營企業的投資比例撇銷，惟有證明顯示未變現虧損是由於所轉撥資產出現減值則除外。收購合營企業產生的商譽計入作為本集團於合營企業投資的一部分。

倘於一間合營企業的投資成為於一間聯營企業的投資，則保留權益不會重新計量。反之，該投資繼續按權益會計法列賬。於所有其他情況下，於失去合營企業的共同控制權時，本集團會按其公平值計量及確認任何保留投資。於失去共同控制權時，合營企業的賬面值與保留投資公平值及出售所得款項的任何差異均於損益中確認。

Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement.

The Group recognises in relation to its interest in a joint operation:

- its assets, including its share of any assets held jointly;
- its liabilities, including its share of any liabilities incurred jointly;
- its revenue from the sale of its share of the output arising from the joint operation;
- its share of the revenue from the sale of the output by the joint operation; and
- its expenses, including its share of any expenses incurred jointly.

The assets, liabilities, revenues and expenses relating to the Group's interest in a joint operation are accounted for in accordance with the HKFRSs applicable to the particular assets, liabilities, revenues and expenses.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

於初始確認後，商譽按成本減任何累計減值虧損計量。商譽每年進行一次減值測試，或倘發生任何事件或情況變動顯示賬面值可能減值時，進行減值測試的次數將更為頻密。本集團於每年三月三十一日進行商譽減值測試。就減值測試而言，自收購日期開始在業務合併所取得之商譽會分配至預期將可受惠於合併之協同效益的本集團現金產生單位或各組現金產生單位（不論本集團其他資產或負債是否分配至該等單位或該等組別）。

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the cash-generating unit retained.

Fair value measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than deferred tax assets, contract assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and any leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as detailed in the policy under “Property, plant and equipment and depreciation” above.

(b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income and gains in profit or loss operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income.

Where the Group is the lessee, rentals payable under operating leases net of any incentives received from the lessor are charged to profit or loss on the straight-line basis over the lease terms.

Investments and other financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. In order for a financial asset to be classified and measured at amortised cost, it needs to give rise to cash flows that are solely payments of principal and interest (“SPPI”) on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group’s business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

為使金融資產按攤銷成本進行分類及計量，其需產生純粹支付未償還本金額的本金及利息(「純粹支付本金及利息」)的現金流量。不論其業務模式，擁有並非純粹支付本金及利息的現金流量的金融資產按公平值計入損益進行分類及計量。

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments which the Group had not irrevocably elected to classify at fair value through other comprehensive income.

A derivative embedded in a hybrid contract, with a financial liability or non-financial host, is separated from the host and accounted for as a separate derivative if the economic characteristics and risks are not closely related to the host; a separate instrument with the same terms as the embedded derivative would meet the definition of a derivative; and the hybrid contract is not measured at fair value through profit or loss. Embedded derivatives are measured at fair value with changes in fair value recognised in profit or loss. Reassessment only occurs if there is either a change in the terms of the contract that significantly modifies the cash flows that would otherwise be required or a reclassification of a financial asset out of the fair value through profit or loss category.

A derivative embedded within a hybrid contract containing a financial asset host is not accounted for separately. The financial asset host together with the embedded derivative is required to be classified in its entirety as a financial asset at fair value through profit or loss.

按攤銷成本計量的金融資產其後使用實際利率法計量，並可能須進行減值。當資產終止確認、修訂或減值時，收益及損失於損益中確認。

按公平值計入損益的金融資產

按公平值計入損益的金融資產於財務狀況表按公平值列賬，公平值的淨變動則於損益確認。

此分類包括本集團並無已不可撤回地選擇分類為按公平值計入其他全面收入的衍生工具。

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset is in default when its contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

金融資產減值

本集團確認對並非按公平值計入損益的所有債務工具預期信貸損失(「預期信貸損失」)之撥備。預期信貸損失乃基於根據合約到期的合約現金流量與本集團預期收取的所有現金流量之間的差額而釐定，並以原實際利率的近似值貼現。預期現金流量將包括出售所持抵押的現金流量或組成合約條款的其他信貸提升措施。

一般方法

預期信貸損失分兩階段確認。就自初始確認以來信貸風險並無大幅增加的信貸風險而言，本集團會就未來12個月可能發生違約事件而出現的信貸損失計提預期信貸損失撥備(12個月預期信貸損失)。就自初始確認以來信貸風險大幅增加的信貸風險而言，不論違約時間，須就風險餘下年期的預期信貸損失作出信貸損失撥備(全期預期信貸損失)。

於各報告日期，本集團評估金融工具的信貸風險自初始確認以來有否大幅增加。於進行評估時，本集團比較金融工具於報告日期的違約風險與金融工具於初始確認日期的違約風險，並考慮毋需過多成本或努力可得的合理支持資料，包括歷史及前瞻性資料。

倘合約付款逾期90日，本集團視金融資產違約。然而，於若干情況下，倘於考慮本集團持有的任何信貸加強措施前內部或外部資料顯示本集團不大可能悉數收取未償還的合約金額，則本集團亦會視金融資產違約。倘並無合理預期收回合約現金流量，金融資產會予以撇銷。

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for accounts receivable and contract assets which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

Simplified approach

For accounts receivable and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings, or as payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include accounts and other payables, an amount due to a joint venture and interest-bearing bank loans.

Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

就具備重大融資成分的應收賬款及合約資產以及應收租金，本集團選擇採納簡化方式為其會計政策，按如上文所述政策計算預期信貸損失。

金融負債

初始確認及計量

於初始確認時，金融負債分類為貸款及借款，或應付款(倘適用)。

所有金融負債初始按公平值確認，如屬貸款及借款以及應付款則按公平值扣除直接應佔交易成本確認。

本集團的金融負債包括應付賬款及其他應付款、應付一間合營企業款項及計息銀行貸款。

後續計量

金融負債的後續計量視乎其分類如下：

按攤銷成本計量的金融負債(貸款及借款)

於初始確認後，計息貸款及借款其後採用實際利率法按攤銷成本計量，倘折現的影響不重大，則按成本列賬。收益及損失在負債終止確認時透過實際利率法攤銷程序於損益中確認。

計算攤銷成本時亦會計及收購所產生的任何折讓或溢價，以及作為實際利率一部分的費用或成本。實際利率攤銷計入損益的財務費用。

Financial liabilities (continued)

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in “Impairment of financial assets”; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

財務擔保合約

本集團發出的財務擔保合約指要求支付指定金額，以償付持有人因指定債務人未能根據債務工具條款依期還款而招致損失的合約。財務擔保合約初始按其公平值確認為負債(就發出該擔保直接應佔交易成本予以調整)。於初步確認後，本集團按以下兩者中較高者計量財務擔保合約：(i)根據「金融資產減值」所載政策釐定的預期信貸損失撥備；及(ii)初步確認的金額減(倘適用)累計已確認收入。

終止確認金融負債

金融負債於負債的責任已解除或註銷或屆滿時終止確認。

當現有金融負債為同一出借人以重大不同的條款的一項負債取代時，或現有負債的條款出現重大修改時，有關交換或修改被視為解除確認原有負債及確認一項新負債，而各賬面值的差額於損益內確認。

抵銷金融工具

倘現時存在可強制執行合法權利抵銷已確認金額，且有意以淨額結算，或同時變現資產及清償負債，則金融資產及金融負債將予抵銷，且以淨金額於財務狀況表呈報。

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

The Group recognises provision for onerous contracts when the unavoidable costs of meeting the performance obligations under the construction contracts exceed the economic benefits expected to be received under them. The amount of provision for onerous contracts is estimated based on contract costs to completion and contract claims. The estimation basis is reviewed on an ongoing basis and revised where appropriate.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the profit or loss.

現金及現金等值物

就綜合現金流量表而言，現金及現金等值物包括所持現金及活期存款，以及可隨時兌換為已知金額現金及所涉價值變動風險不高，且一般自取得起計三個月內到期的短期高流動性投資，減須按要求償還且構成本集團現金管理的組成部分的銀行透支。

就綜合財務狀況表而言，現金及現金等值物包括用途不受限制的手頭及銀行現金(包括定期存款)以及性質與現金相似的資產。

撥備

當過去事項導致目前須負之責任(法律或推定)，且日後有可能需要撥付資源償付有關責任所涉及之款項，則會確認撥備，惟該項責任之數額須能夠可靠地予以估計。

倘根據建築合約履行履約責任的不能避免成本超出預期自該合約取得的經濟利益，則本集團確認虧損性合約撥備。虧損性合約撥備金額按竣工的合約成本及合約申索估計。本集團會持續審閱估計基準並在適當時予以修訂。

當折現之影響屬於重大，撥備確認之數額為預期日後償付有關責任所需支出於報告期末之現值。已折現現值隨時間而有所增加，有關增幅會計入損益之財務費用。

Income tax

Income tax comprises current and deferred taxes. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. - when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

收入確認

來自客戶合約之收入

本公司按能反映本集團預期將就向客戶轉讓貨品或服務而有權換取的代價金額於貨品或服務的控制權轉移至客戶時確認來自客戶合約之收入。

倘合約代價包括可變金額，代價金額則按本集團向客戶轉讓貨品或服務而將有權換取的金額作估計。可變代價於訂立合約時作估計及受限，直至可變代價的相關不確定因素其後獲解決，且已確認的累計收入金額很大機會不會出現重大收入撥回。

倘合約包括就向客戶轉讓貨品或服務撥資向客戶提供重大利益逾一年之融資成份，收入乃按應收款的現值計量，並以訂立合約時本集團與客戶的個別融資交易中反映的折現率折現。倘合約包括向本集團提供重大財務利益逾一年之融資成份，根據合約確認的收入包括合約負債按實際利息法計算的利息開支。就客戶付款與轉移承諾貨品或服務的期間為一年或以下的合約，交易價格將使用香港財務報告準則第15號的可行權宜方式，不會就重大融資成份的影響作出調整。

Revenue from contracts with customers (continued)

Construction services

Revenue from the provision of construction services is recognised over time, using an output method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls overtime as the asset is created or enhanced. The output method recognises revenue in accordance with the direct measurements of the value of the services transferred by the Group to the customer with reference to the certified value of work performed to date.

Other income

Rental income is recognised on a time proportion basis over the lease terms.

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Contract assets

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets.

來自客戶合約之收入(續)

建築服務

來自提供建築服務的收入隨時間確認，並使用產出法計量完全履行服務的進度，因本集團的履約創建或增強資產，而該資產創建或增強時由客戶控制。產出法根據經參考迄今已施工工程的經核定價值直接計量本集團向客戶轉移之服務的價值確認收入。

其他收入

租金收入按時間比例於租期內確認。

利息收入按預提基準利用實際利息法確認，而實際利息法指透過預期金融工具年期或較短年期(如適用)內收取之估計未來現金收益精確地折現至金融資產賬面淨值之利率。

合約資產

合約資產乃向客戶轉移貨品或服務以換取代價之權利。倘本集團通過於客戶支付代價前或於付款到期前將貨品或服務轉移至客戶來履約，則會就所賺取之有條件代價確認合約資產。合約資產須接受減值評估，其詳情載於有關金融資產減值的會計政策。

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods and services to the customer).

Contract costs

Other than the costs which are capitalised as inventories, property, plant and equipment and intangible assets, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to the profit or loss on a systematic basis that is consistent with the pattern of the revenue to which the asset related is recognised. Other contract costs are expensed as incurred.

當本集團轉移相關貨品或服務前，收到客戶的款項或應付款(以較早者為準)時，確認合約負債。當本集團根據合約履約(即將相關商品及服務的控制權轉移至客戶)時，合約負債確認為收益。

合約成本

除已資本化為存貨、物業、機器及設備及無形資產的成本外，倘符合以下所有準則，為履行與客戶的合約而產生的成本會資本化為資產：

- (a) 與合約或實體能具體辨識之預期合約直接相關的成本。

- (c) 預期收回的成本。

Share-based payments

The Company operates share option schemes for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group may receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

以股份為基礎的付款

本公司設有購股權計劃，以獎勵及回報對本集團業務成就作出貢獻之合資格參與者。本集團僱員(包括董事)可能以股份為基礎的支付方式收取報酬，僱員提供服務作為收取股本工具之代價(「以股權支付之交易」)。

對於與僱員進行以股權支付之交易之成本，乃參照交易授出日期之公平值而計量。

以股權支付之交易之成本，連同權益相應增加部分，在績效及／或服務條件獲履行期間於僱員福利開支內確認。在歸屬日期前，每個報告期末確認之以股權支付之交易之累計開支，反映歸屬期已到期部分及本集團對最終將會歸屬之股本工具數目之最佳估計。在某一期間內在損益賬內扣除或進賬，乃反映累計開支在期初與期末確認時之變動。

釐定購股權的授出日期公平值時並不考慮服務及非市場表現條件，惟能達成條件的可能性則被評定為本集團對最終歸屬為股本工具數目的最佳估計之一部分。市場表現條件反映於授出日期的公平值。附帶於購股權中但並無相關聯服務要求的任何其他條件均被視為非歸屬條件。非歸屬條件反映於購股權的公平值，除非同時具服務及／或績效條件，否則購股權即時支銷。

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

因非市場績效及／或服務條件未能達成而最終並未歸屬的獎勵不會確認為開支。凡獎勵包含市場或非歸屬條件，無論市場條件或非歸屬條件獲履行與否，倘所有其他績效及／或服務條件均獲履行，則交易被視為一項歸屬。

倘若以股權支付之購股權條款有所變更，且已符合購股權之原定條款，所確認開支最少須達到猶如條款並無任何變更之水平。此外，倘若按變更日期計量，任何變更導致以股份為基礎的支付之總公平值有所增加，或對僱員帶來其他利益，則應就該等變更確認開支。

Other employee benefits

Paid leave carried forward

The Group provides paid annual leave to its employees under their employment contracts on a calendar year basis. Under certain circumstances, such leave which remains untaken as at the end of the reporting period is permitted to be carried forward and utilised by the respective employees in the following year. An accrual is made at the end of the reporting period for the expected future cost of such paid leave earned during the year by the employees and carried forward.

Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees’ basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme.

The Group also operates a Mandatory Provident Fund Exempted Occupational Retirement Schemes Ordinance (“ORSO”) retirement benefit scheme for those employees who are eligible to participate in the ORSO scheme. This scheme operates in a way similar to the MPF Scheme, except that when an employee leaves the scheme prior to his/her interest in the Group’s employee contributions vesting fully, the ongoing contributions payable by the Group are reduced by the relevant amount of forfeited employer’s contributions.

退休福利計劃

本集團已按照強制性公積金計劃條例為所有合資格參與強積金計劃之僱員設有定額供款強制性公積金退休福利計劃(「強積金計劃」)。供款乃按照僱員底薪百分比計算，當需要按照強積金計劃條款規定供款時，即在損益中扣除有關供款。強積金計劃資產乃由獨立管理基金持有並與本集團資產分開管理。當向強積金計劃供款時，本集團之僱主強制供款將全數歸於僱員所得。

本集團亦為合資格參與強制性公積金豁免職業退休計劃條例(「職業退休計劃條例」)計劃之僱員設有職業退休計劃條例計劃。該計劃以類似強積金計劃之方式經營，惟當僱員於符合資格全數享有本集團僱員供款前離職，則本集團須持續支付之供款可扣除被沒收僱主供款之有關款額。

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Interim dividends can be simultaneously proposed and declared, because the Company's articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Proposed final dividends are disclosed in the notes to the financial statements.

Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Differences arising on settlement or translation of monetary items are recognised in profit or loss with the exception of monetary items that are designated as part of the hedge of the Group's net investment of a foreign operation. These are recognised in other comprehensive income until the net investment is disposed of, at which time the cumulative amount is reclassified to profit or loss. Tax charges and credits attributable to exchange differences on those monetary items are also recorded in other comprehensive income.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas joint ventures are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in other reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for these portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

投資物業及自用物業的分類

本集團確定一幢物業是否可列作投資物業，並已制定判斷之準則。投資物業乃持作賺取租金或資金增值或持作兩者之物業。因此，本集團考慮一幢物業在產生現金流量時，是否大都獨立於本集團所持有之其他資產。若干物業包括乃持作賺取租金或資本增值的部分，及持作生產或供貨或提供服務或作行政管理用途的部分。如該等部分能獨立出售或以融資租賃方式獨立出租，本集團將該等部分單獨入賬。如該等部分不能獨立出售，該物業僅在持作生產或供貨或提供服務或作行政管理用途佔極少部分時列作投資物業。本集團對各項物業作出判斷，以確定配套服務是否重要致使物業不符合投資物業的資格。

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Accounting for contract works

The Group's revenue from contract works is recognised over time using the output method and is measured in accordance with the progress towards complete satisfaction of the performance obligations. Budgeted contract costs are prepared by management on the basis of contract concluded with and/or quotations provided by major sub-contractors, suppliers or vendors involved from time to time, the experience of management and current market condition. The estimation of profitability of each project is dependent on the estimation of the total outcome of the contract, as well as the work done to date. The Group reviews and revises the estimates of contract costs to completion, variation orders and contract claims prepared for each contract as the contract progresses. Significant judgement is required in estimating contract costs to completion, variation works and contract claims which may have an impact to the total outcome of the contract and recognition of profit. Actual outcomes of total contract costs and total revenue may be higher or lower than that estimated at the end of the reporting period, which would affect the profit recognised in future years as an adjustment to the amounts recorded to date.

Estimation uncertainty (continued)

Recoverability of accounts receivable and contract assets

The policy for impairment of trade receivables and contract assets of the Group is based on the evaluation of collectability and ageing analysis of trade receivables and contract assets as well as other quantitative and qualitative information and on management's judgement and assessment of the forward-looking information. Significant judgement and estimates are required in assessing the ultimate realisation of these assets, based on the current creditworthiness, the past collection history and subsequent settlements of each customer. If the financial conditions of customers of the Group were to deteriorate, resulting in an impairment of their ability to make payments, additional provisions may be required. Further details are disclosed in notes 18, 19 and 35 to the financial statements.

5. OPERATING SEGMENT INFORMATION

For management purposes, the Group has only one reportable operating segment which is the contract works segment. The contract works segment engages in contract works, acting as a main contractor or sub-contractor, primarily in respect of building construction and RMAA works. Accordingly, no segment information is presented. Further details of the Group's revenue from building construction and RMAA works are set out in note 6 to the financial statements.

The Group's revenue from external customers was derived solely from its operations in Hong Kong and the non-current assets of the Group were all located in Hong Kong.

Credit risk

The Group's credit risk is primarily attributable to contract assets, accounts receivable, financial assets included in prepayments, other receivables and other assets and cash and bank balances. The Group's maximum credit risk exposure at the end of each reporting period in the event of other parties failing to perform their obligations is represented by the carrying amounts of financial assets as stated in the consolidated statement of financial position.

Management monitors the creditworthiness and payment patterns of each debtor closely and on an ongoing basis. The Group's accounts receivable and contract assets from contract works represent interim payments or retentions certified by the customers under terms as stipulated in the contracts and the Group does not hold any collateral over these accounts receivable and contract assets. As the Group's customers in respect of contract works primarily consist of government departments and developers or owners with strong financial backgrounds, management considers that the risk of irrecoverable receivables from contract works is not significant.

At 31 March 2020, the Group had certain concentrations of credit risk as 42% (2019: 66%) and 97% (2019: 91%) of the total accounts receivable and contract assets were due from the Group's largest external customer and the Group's five largest external customers, respectively, within the contract works segment.

The Group has applied the simplified approach to provide for impairment for ECLs prescribed by HKFRS 9, which permits the use of the lifetime expected loss provision for impairment of all accounts receivable and contract assets. To measure the ECLs, accounts receivable and contract assets have been grouped based on shared credit risk characteristics and the days past due. With the incorporation of forward-looking information in the ECLs, management considered that the ECL rate for the Group's accounts receivable and contract assets is minimal and therefore no provision for impairment of accounts receivable and contract assets was necessary as at 31 March 2020 and 2019.

An impairment analysis is performed at each reporting date using a provision matrix to measure expected credit losses. The provision rates are based on days past due for groupings of various customer segments with similar loss patterns. The calculation reflects the probability-weighted outcome, the time value of money and reasonable and supportable information that is available at the reporting date about past events, current conditions and forecasts of future economic conditions.

An impairment analysis is performed throughout the reporting period, which is estimated by applying the probability of default approach with reference to the risks of default of the debtors or comparable companies.
