This announcement is made by Tongda Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) to provide shareholders and investors of the Company with information in relation to the unaudited consolidated financial results of its non-wholly owned subsidiary, 廈門市通達創智實業有限公司 (Tongda Smart Tech (Xiamen) Company Limited*) (“**Tongda Chuang Zhi**”), for the three months ended 31 March 2024.

Tongda Chuang Zhi is a company incorporated in the People’s Republic of China (the “**PRC**”) whose issued shares are listed on the Shenzhen Stock Exchange. As at the date of this announcement, Tongda Chuang Zhi is controlled by the Company as to approximately 66.4%. Tongda Chuang Zhi has announced its unaudited financial information for the three months ended 31 March 2024 (the “**Tongda Chuang Zhi Quarterly Results**”), which are prepared under the PRC accounting standards. The summary of the key unaudited consolidated financial information of Tongda Chuang Zhi as extracted from the Tongda Chuang Zhi Quarterly Results is set out below.
