Where there are joint holders of any share of the Company, any one of such joint holders may vote at the meeting, either in person or by proxy, in respect of such share as if he/she/it were solely entitled thereto, but if more than one of such joint holders be present at the meeting, the vote of the senior who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holders, and for this purpose, seniority shall be determined as that one of the said persons so present whose name stands first on the register of members in respect of such share shall alone be entitled to vote in respect thereof.

A proxy will also be entitled to vote at his/her discretion on any resolution properly put to the AGM other than those set out in the notice of the AGM. Any vote which is not filled or filled wrongly or with unrecognisable writing or not cast will be deemed as having been waived by you and the corresponding vote will be counted as "ABSTAIN".
- This supplemental form of proxy must be signed and dated by a shareholder, or his/her attorney duly authorised in writing, or if the shareholder is a corporation, either under its common seal or under its director or duly authorised person. All powers of attorney referred to in this note must be notarially certified.
- As regards the holders of the H shares and in order to be valid, this supplemental form of proxy, together with any power of attorney or other authority (if any), under which it is signed or a notarially certified copy of such power of attorney or authority, must be deposited with the Company's H share registrar, Boardroom Share Registrars (HK) Limited at Room 2103B, 21/F., 148 Electric Road, North Point, Hong Kong no later than 24 hours before the time appointed for holding the AGM or its adjournment.
- As regards the holders of the domestic shares and in order to be valid, this supplemental form of proxy, together with any power of attorney or other authority (if any), under which it is signed or a notarially certified copy of such power of attorney or authority, must be deposited with the Company's registered office address at the Office of the Board of Directors, 238 Yunlin Middle Road, Wangchun Industrial Park, Ningbo, Zhejiang Province, the PRC no later than 24 hours before the time appointed for holding the AGM or its adjournment.
- This supplemental proxy form is applicable to the supplemental resolution as set out in the supplemental notice of the AGM dated 20 May 2026 and supplements the original proxy form. This supplemental proxy form will not affect the validity of the original proxy form duly completed by you in respect of the resolutions set out in the notice of the AGM dated 21 April 2026. If you have validly appointed a proxy to attend the AGM but do not complete and deliver this supplemental form of proxy, your proxy will be entitled to vote at his/her discretion on the resolution set out in the supplemental notice of the AGM dated 20 May 2026. If you have not yet completed and returned the original form of proxy for the AGM but have completed and returned this supplementary proxy form and have validly appointed a proxy to attend the AGM, your proxy shall be entitled to vote on your behalf, at his or her discretion, on the resolutions set out in the notice of the AGM dated 21 April 2026.**
- A proxy attending the AGM on behalf of a shareholder must present the proxy's proof of identity together with any power of attorney or other authority (if any).
- Any alteration made to this supplemental form of proxy should be initialled by the person who signs this supplemental form of proxy.
- Unless the context requires otherwise, terms defined in the notice of the AGM shall bear the same meanings when used in this supplemental form of proxy.
- Completion and delivery of this supplemental form of proxy will not preclude you from attending and voting in person at the AGM and its adjournment if you so wish. You must present your proof of identity when you attend and vote in person at the AGM.
