To the best of the Directors' knowledge, belief and information, no Shareholders had a material interest in the resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 17.47A of the Rule Governing the Listing of Securities on GEM (the "**GEM Listing Rules**") of the Stock Exchange. No Shareholder was required under the GEM Listing Rules to abstain from voting at the AGM and no Shareholders have stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.

Tricor Investor Services Limited, the Company's branch share registrar and transfer office in Hong Kong, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

The Directors, namely Mr. LI Kin Shing, Mr. MA Yuanguang, Mr. WONG Kin Wa, Mr. LEUNG Kwok Keung, Mr. CHEUNG Sai Ming and Ms. LEUNG Hoi Ning have attended the AGM either in persons or by electronic means.
